President Report:

- Eric A. reported on the balance-\$536.69 with no transactions in the past year. BB&T is now Truist. Eric reminded Council reps to work with their Treasurer at the next meeting to complete the IRS Tax filing and also Annual Financial reporting to FCG/DPR.
- Shawn C. reported that WNMRC has been working to get reinstated as exempt 501C3 and is waiting on response from IRS

Round-Table:

- **Ballenger Creek** John C. reported on the BCRC basketball programs over the winter and the start-up of soccer for the spring. Soccer registration is still open.
- Brunswick Area Mary B. reported on the three (3) events that BARC ran since the last meeting: Jingle Bell Run, accepting donation for the food bank, Freezin for a Reason had 15 people get in the river, Forest of Needwood Race 30 people ran and the scholarship that benefits local service member. The Scottish First footing event was cancelled due to managing member down with covid.
- CMRC Greg R. reported on the winter basketball season and the challenges with enforcing
 masking requirements, FCPS locations gym times and getting Officers/Commissioners to attend
 meetings. Spring sports Baseball, LAX and Soccer are starting. Greg R. discussed the challenges
 with FCPS requiring supplemental insurance for field maintenance equipment on FCS property

- Nature Dana C. reported on the council's use of the Benevity application where volunteers can donate time and funds through the application. Dana asked if there were any restrictions for that. Master Naturalists are planting and buying plants from a specific nursery that offers discounts to them. Any issues with that? Eric A. stated there were no issues with those processes but that it is very important to document all transactions and include detailed notes as needed especially for all financial transactions.
- **Senior** not present
- Urbana Jason C. reported on the completion of winter season sports wrestling program went well. There were issues with basketball gym availability through FCPS. Spring sports are starting baseball, lacrosse and basketball. Registration is steady. URC is concerned that Campus Drive fields may not be available for the fall since URC starts practice in late July. Eric A. stated he would request an update on fields. Jason C. informed of the elections and he would send the info on new officers.
- Woodsboro/New Midway Shawn C. reported on the winter basketball program having three (3) teams and the open gym. Good turnout and the teams were either in the finals or came close. Baseball season starts this weekend. There were 3 teams last year and 5 this year so they have grown some over last 2 seasons. Council is planning to hold a celebration later in the season similar to an opening day celebration to promote the council. The soccer program has been hard to establish and may be due to the Director coaching at Walkersville currently. There are a lot of certification requirements for soccer coaching.

Additional discussion: Jason C. asked if there were any questions or items for the good of the order. Dana C. asked if anyone had suggestions on advertising and promoting. Jason C. mentioned that URC uses social media and that he felt using the enrollment database doesn't get new people. Greg R. suggested to contact the local PTAs and get on their private newsletter. Shawn C. suggested contacting teachers that take the field trips at nature centers
